INTRODUCTION

MEI is the abbreviation used for the condition of individual microentrepreneur. It is a legal way to formalize entrepreneurs who have a turnover of up to R\$ 81,000.00 per year. In addition to this requirement, the entrepreneur must not participate as a partner in any other company.

Among the numerous advantages, the possibility of the MEI to hire up to one employee stands out.

Several economic activities can be classified as MEI, according to the so-called CGSN Resolution No. 140, of 2018.

The immigrant can also formalize himself as an individual microentrepreneur using the official digital platform of the Brazilian federal government: Gov.br.

This manual will allow migrants to register and use all the benefits of this legal status.

In Brazil, many workers carried out their activities in a completely informal way. This reality began to change with the creation of the MEI condition, which allowed the formalization of various activities at a relatively low cost.

The Individual Microentrepreneur (MEI) condition is an entrepreneur who, with a small business, has his condition completely legalized.

The MEI registry was implemented by the Brazilian government to allow millions of people to leave their informal status. With the creation of the MEI, many professionals were formalized, and started to have access to the benefits of this category, such as retirement and maternity leave.

The MEI was instituted by the complementary law 128/2008, which modified the General Law for Micro and Small Enterprises, and thus created the Individual Microentrepreneur.

With the current legislation, more than 6 million people have formalized themselves as MEI in Brazil.

Discover the benefits of being MEI:

- retirement;
- sickness aid;
- maternity assistance;
- ease of opening accounts
- and obtaining credit;
- issuance of invoices;
- reduction in the number of taxes.

To open the MEI, the microentrepreneur must access the website: www.gov.br, with his CPF in hand. In addition to this document, also have your full address at hand, and know beforehand the code of the commercial activity in which you will act.

For those who do not have a defined activity, but wish to open their own business, it is important that they develop their business model before formalizing themselves as MEI.

The collection of all taxes for those who have the MEI is unified by the Simples Nacional regime, in addition to the exemption from all federal taxes, such as the income, for example.

To be entitled to this benefit, payment is required. of the DAS (Monthly Collection Document). payment is monthly and has a value fixed in advance.

Check the values:

Provision of Services: R\$ 5 of ISS Industry or Commerce: R\$ 1 of ICMS

Commerce and Services: R\$ 6 of ICMS/ISS INSS: 5% of the current minimum wage

Considering these values, check the total value for activities:

Industry or Commerce: BRL 56.00 Provision of Services: BRL 60.00 Trade and Services: BRL 61.00

Every year, the entrepreneur is required to present the Annual Billing Statement, called DASN-Simei. This document is for the entrepreneur to inform what his gross income was in the year.

It is also important to know that the worker with a work card, duly registered, can also be MEI, but may lose the right to unemployment insurance in case of dismissal by the employer.

By formalizing themselves as MEI, foreigners also gain many benefits for their ventures.

Check out:

- * Lower monthly payment to get your retirement
- * Condition to be hired to work in companies, in condition of MEI
- * Obtaining credit from financial institutions, with interest rates lower than the market average



Attention: If you have already declared income tax, you will need to inform your Individual Income Tax receipt number.

- Step 3: Enter the Gov.br platform
- Step 4: If you are already registered on the Gov.br platform, enter your CPF and password. Otherwise, just create your account providing the requested data
- 5th Step: Fill in the requested data, informing the activity you will develop. There are more than 400 activities allowed through MEI
- Step 6: Check the data and click on Confirm
- Ready! You are now an Individual Microentrepreneur, and will be able to access:
- Proof of MEI (CCMEI)
- CNPJ card
- The first monthly contribution slip: DAS
